

**AMENDMENT #11
TO AGREEMENT

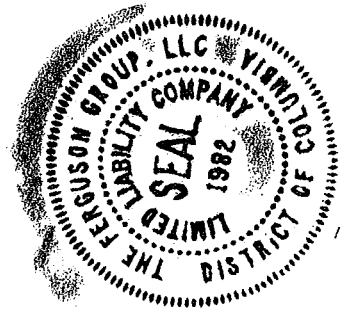

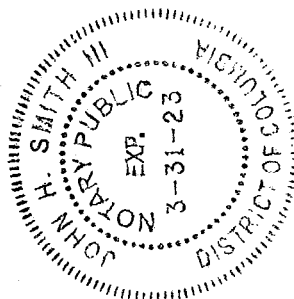
