A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF TAMARAC, FLORIDA, AUTHORIZING A PURCHASE AGREEMENT WITH FLORIDA DESIGN DRILLING CORPORATION (FDD) FOR THE WATER TREATMENT PLANT WELLS 15, 16 AND 17 PROJECT AUTHORIZING AN EXPENDITURE OF FUNDS FOR AN AMOUNT NOT TO EXCEED \$243,269.70 INCLUDING A CONTINGENCY IN THE AMOUNT OF \$29,192.36 FOR A PROJECT TOTAL NOT TO EXCEED \$272,462.06; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Tamarac Water Treatment Plant (WTP) has 19 raw water wells and began the Raw Water Well Rehabilitation Program in 2014; and

WHEREAS, sixteen (16) raw water wells have been upgraded and this project will complete the Rehabilitation Program and upgrade the three (3) remaining wells; and

WHEREAS, Florida Design Drilling Corporation (FDD) have successfully completed four (4) other City wells recently; and

WHEREAS, Public Services Staff determined Broward County Bid Number OPN2118442B1 has favorable pricing, terms, and conditions, which was awarded on June 28, 2019, and is valid beginning August 16, 2019 through August 15, 2020, a copy of the Pricing Bid Tab for Bid No. OPN2118442B1 Pricing Tab is attached hereto as "Exhibit 1"; and

WHEREAS, FDD agrees to allow the City of Tamarac to utilize the existing Contract with Broward County (Bid No. OPN2118442B1) with the same terms, conditions, specifications and pricing, a copy of the pricing proposal is attached hereto as "Exhibit 2"; and

WHEREAS, Public Services Staff have determined the cost proposal is consistent with the pricing of Bid No. OPN2118442B1, and the Contract is valid through August 15, 2020, and a copy of Bid No. OPN2118442B1 is incorporated herein by reference and is on file at the Office of the City Clerk; and

WHEREAS, it is the recommendation of the Director of Public Services, Director of Financial Services, and the Purchasing & Contracts Manager that the City Commission authorize an expenditure in an amount not to exceed \$243,269.70 including a contingency in the amount of \$29,192.36 for a project total not to exceed \$272,462.06.

WHEREAS, the City Commission of the City of Tamarac, Florida deems it to be in the best interest of the citizens and residents of the City of Tamarac to approve and to authorize the appropriate City Officials to an issue a Purchase Order in an amount not to exceed \$243,269.70 including a contingency in the amount of \$29,192.36 for a project total not to exceed \$272,462.06 for the stated purpose of the WTP Wells 15, 16 and 17 Rehabilitation Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TAMARAC, FLORIDA, THAT:

SECTION 1: The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof, and all exhibits referenced and attached hereto are incorporated herein and made a specific part of this Resolution.

SECTION 2: The City Commission HEREBY approves the procurement of Raw Water Well Rehabilitation Services utilizing Bid No. OPN2118442B1 solicited and awarded by Broward County Board of County Commission not to exceed \$243,269.70 including a contingency in the amount of \$29,192.36 for a project total not to exceed \$272,462.06.

SECTION 3: Expenditures for Raw Water Well Rehabilitation per Broward County Bid No. OPN2118442B1 are hereby authorized and shall not exceed \$243,269.70 including a contingency in the amount of \$29,192.36 for a project total not to exceed

\$272,462.06.

SECTION 4: The City Manager, or his designee, is hereby authorized to approve and initiate Change Orders in amounts not to exceed \$65,000 per Section 6-147 of the City Code, and close the contract award, which includes but is not limited to making final payment and releasing bonds per Section 6-149 of the City Code, when the work has
