RESOLUTION NO. R-2020-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF TAMARAC, FLORIDA, TO APPROVE AND EXECUTE THE FIRST AMENDMENT TO THE PARTICIPATION AGREEMENT FOR E911 COMMUNICATION SYSTEM BETWEEN BROWARD COUNTY AND THE CITY OF TAMARAC AND PERMIT MUNICIPALITIES TO PROCURE SPECIAL MUNICIPAL SERVICES ABOVE THE BASE LEVEL OF SERVICES WITH AN EFFECTIVE DATE OF JANUARY 1, 2021 AND WITH A TERM OF FIVE (5) YEARS; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE FIRST AMENDMENT TO THE PARTICIPATION AGREEMENT FOR E911 COMMUNICATION SYSTEM; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in September 2009, the City entered a Regional Interlocal Agreement (RILA) with the Broward Sheriff to provide interoperability by interconnecting to the Sheriff Public Communication and Computer Aided Dispatching System; and

WHEREAS, in October 2012, Broward County took over the operation of the Regional Communication System and became the operator of the system; and

WHEREAS, an Assignment, Delegation and Release Agreement that assigned the existing RILA from Broward Sheriff to Broward County was executed and approved via Resolution R-2013-103 on September 17, 2013 Commission Meeting, (R-2013-103 is on file at the City Clerk's Office); and

WHEREAS, this First Amendment to the Participation Agreement will be used to direct the efficient operation of the Regional Consolidated Public Safety Dispatch System while delineating the responsibilities of all participants; and

WHEREAS, this First Amendment to the Participation Agreement is needed to align the performance standards and engagement process with the Operator Agreement the County has with the Broward Sheriff's Office; to ensure compliance with Criminal Justice Information System or Florida Department of Law Enforcement requirements; and

WHEREAS, the County Administrator is requesting that each City Commission approve the First Amendment to the Participation Agreement no later than September 1, 2020 (attached hereto as Exhibit B); and

WHEREAS, the First Amendment to the Participation Agreement's terms and conditions remain in full force and effect, except for the amendments and revisions shown on said Agreement; and

WHEREAS, the effective date of the First Amendment to the Participation Agreement is January 1, 2021 for a term of five (5) years; and

WHEREAS, it is the recommendation of the Fire Chief that Tamarac participate in the First Amendment to the Participation Agreement for E911 Communications System; and

WHEREAS, the City Commission of the City of Tamarac, Florida deems it to be in the best interest of the citizens and residents of the City of Tamarac to approve the First Amendment to the Participation Agreement for E911 Communications System (attached hereto as Exhibit A)

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF
THE CITY OF TAMARAC, FLORIDA:

SECTION 1: The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution. All Exhibits attached hereto are expressly incorporated herein and made a part hereof.

SECTION 2: That the City Commission hereby approves the First Amendment to the Participation Agreement for E911 Communications System between the City of Tamarac and Broward County. The appropriate City Officials are hereby authorized to execute the First Amendment to the Participation Agreement for E911 Communications System (attached hereto as Exhibit A).

SECTION 3: All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: If any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or application, it shall not affect the validity of the remaining portions or applications of this Resolution.

SECTION 5: This Resolution shall become effective immediately upon its passage and adoption.
