AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF TAMARAC, FLORIDA, AMENDING ARTICLE III OF THE CODE OF ORDINANCES **ENTITLED** "BOARDS. COMMITTEES. COMMISSIONS" SPECIFICALLY AMENDING SEC. 2-58(A) "APPLICATION PROCESS" BY PROVIDING FOR DISCRETION AND FLEXIBILITY WHEN ADVERTISING **BOARD** FOR AND COMMITTEE VACANCIES: PROVIDING FOR CONFLICTS: **PROVIDING** FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Tamarac has been required to advertise board and committee vacancies in a newspaper of general circulation since 1997; and

WHEREAS, the newspaper of general circulation requirement is rigid, and only applicable to one newspaper in Broward County; and

WHEREAS, the City Commission has recognized there are more local and niche news outlets and other electronic avenues to reach the residents of Tamarac than ever before; and

WHEREAS, the City Commission has requested there be more discretion and flexibility when determining the best publications to use when advertising for board and committee vacancies; and

WHEREAS, the City Commission of the City of Tamarac has deemed it to be in the best interest of the citizens and residents of the City of Tamarac to amend Sec 2-

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE

CITY OF TAMARAC, FLORIDA THAT:

SECTION 1: The foregoing whereas clauses are hereby ratified and confirmed as

being true and correct and are hereby made a specific part of this Ordinance upon

adoption hereof; all exhibits attached hereto are incorporated herein and made a specific

part thereof.

SECTION 2: The City Commission hereby amends Article III: Boards Committees

and Commissions, Sec. 2-58(a) "Application Process" to read as follows.

Section 2-58(a): The City Commission shall request that individuals who meet the

qualification requirements for a specific advisory board and/or committee submit

an application for appointment to a specific advisory board. The city clerk shall

provide notice of the City Commission's request for applications for appointment

to the City's advisory boards and committees through notices posted at city hall,

on the city's web site, and in a local newspaper of general circulation shall have

the discretion and flexibility to advertise in local newspapers or through other

electronic means as necessary.

<u>SECTION 3:</u> It is the intention of the City Commission and it is hereby ordained

that the provisions of this Ordinance shall become and be made a part of the Code of

Ordinances of the City of Tamarac, Florida, and that the Sections of this Ordinance may

be renumbered or relettered and the word "Ordinance" may be changed to "Section", "Article" or such other word or phrase in order to accomplish such intention.

SECTION 4: All Ordinances or parts of Ordinances, and Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given affect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

<u>SECTION 6:</u> This Ordinance shall become effective immediately upon its passage and adoption.
